# Consultation on EC white paper on R&D support for dual-use technologies

The EC published a **White Paper** on options for **enhancing research and development support** for technologies with dual-use potential.

The paper recognises the importance of innovation procurement for dual-use technologies and proposes possible ways to **increase in particular EU funded pre-commercial procurements** in this field.

## Call for pledges of the Mobility Transition Pathway

The European Commission launched a <u>call for pledges</u> to **achieve the green and digital transition** of the EU Mobility Industrial Ecosystem.

Invitation is open to **all organisations**, from SMEs to larger companies, public administration, civil society groups and other interested parties to participate. The call will allow businesses and organisations to showcase what they are doing and intend to do for a more sustainable, digital and resilient mobility industry.



Support Member States' efforts to invest more, better, together, and European

- Joint programming and procurement function
- Support to joint procurement from EDTIB (EDIRPA logic)
- European Military Sales Mechanism

Secure the availability of defence products thanks to a more efficient and responsive EDTIB and an enhanced Security of Supply

- De-risk investments (ASAP logic)
- EU security of supply regime







#### Mainstream a defence readiness culture

- Review of EIB group lending policy
- FAST for access to finance
- Defence readiness, security and resilience as future programmes objectives (e.g. Cohesion funds and InvestEU)
- High level dialogue with financial sector to enhance access to finance



## Leverage partnerships to enhance readiness and resilience

- Promote Ukraine's participation EU defence industry programmes
- EU-Ukraine Defence Industry Forum in 2024
- Enhance NATO-EU staff-to-staff structured dialogue
- Strengthen mutually beneficial partnerships



## Several **indicators** to monitor the implementation

- By 2030, value of intra-EU defence trade = at least
   35% of EU defence market.
- By 2030, at least 50% of procurement from the EDTIB, and 60% by 2035
- By 2030, at least 40% of collaborative procurement










## The Transition pathways

- ☐ Revised 2021 Industrial Strategy called for Transition pathways for the 14 industrial ecosystems
- □Green, digital transitions + resilience of each ecosystem
- □Co-creation process with stakeholders (not a Commission document)
- □8 published, 2 on -going





## Co-creation process

- □ Public consultation: 26 July 3 November 2023
- 4 thematic workshops
- ☐ Prioritisation workshop: ASD expert group, 17 November 2023
- ☐ Decision to split aerospace and defence. EDIS transition pathway for the defence industry
- ☐ Additional consultation civil aeronautics and space industries, February 2024



## The Aerospace Ecosystem

☐ Strategic importance. EU to become a global space player and keep a leadership position on civil aeronautics

#### Space:

- □ EU:PNT- Galileo, EO- Copernicus, IRIS² constellation .
- ☐ MS: national space assets, also serving security and defence purposes
- ☐ Emergence of private sector: New Space phenomenon

#### Civil aeronautics:

☐ One of the EU's most successful high -tech sectors, composed by a network of thousands of businesses which include important big companies

Importance of SME dimension: 80% of the civil aeronautics sub -sector



# Accelerating uptake through open proposals for advanced SME innovation

- The aim of this call is to **support the development of mature technological solutions** aligning with EU security policy priorities, particularly focusing on enabling **SMEs and high-tech startups** to address societal security challenges effectively.
- Activities within proposed projects may include:
  - Facilitating access to additional funding
  - Engaging with potential buyers
  - Offering guidance for market expansion
  - Supporting technology transfer and development for SMEs
- Planned opening date: 27 June 2024

# Non-thematic research actions targeting disruptive technologies for defence

- The objective of this call is to **catalyse the development of groundbreaking technologies** poised to revolutionize defence capabilities, ensuring significant advantages over potential adversaries
- Proposals are expected to:
  - o Develop **innovative solutions** aligned with EU security policy priorities.
  - o Facilitate access to civil security markets for **small innovators**.
  - o **Enhance cooperation** between public buyers and small suppliers.
  - o Strengthen partnerships within the EU security industry to reduce dependency on non-EU suppliers.
