EU-US CLUSTER COOPERATION

Over 70 EU and US clusters and Economic Development Organisations (EDOs) and high-level speakers made the EU-US Cluster Matchmaking Event at Hannover Messe, Germany, on 25-26 April 2016 a great success!

With over 140 bilateral meetings arranged between EU clusters and US clusters, EDOs, businesses and R&D institutions during the Matchmaking Event, the EU-US Cooperation Arrangement on Clusters signed in April 2015 has clearly succeeded in laying the foundations for concrete cooperation actions to take place. The EU-US Cluster Matchmaking Event was organised by the European Commission, DG GROWTH and the US Department of Commerce.

The bilateral C2Cmeeting sessions were complemented by a high level policy seminar on **“Clusters in the EU and the USA: Opportunities for Collaboration and Growth”** with the participation of **Elżbieta Bieńkowska**, EU Commissioner for Internal Market, Industry, Entrepreneurship and SMEs, Bruce Andrews, US Deputy Secretary of Commerce **Bruce Andrews** and **Matthias Machnig**, State Secretary of Germany Federal Ministry for Economic Affairs and Energy who all emphasized the power of clusters to drive forward the innovation process and the importance to bolster transatlantic cluster cooperation.



Caroline Pin, Plastipolis Cluster: “It was a great opportunity to meet with US counterparts from Ohio, Pennsylvania, New Hampshire and Kansas. The US have always been a priority for the cluster being a target country for most of its members. The cluster has signed MOUs with 3 US based partners regarding polymers, composites and bio-based materials. Plastipolis would like to move one step forward by setting up a permanent representation office in the US. It could have a staff member hosted directly in its partner’s premises and working

on networking opportunities and joint projects between France and the US, at academic, technological and business level”

The European Commission's Directorate-General for Internal Market, Industry, Entrepreneurship and SMEs invites cluster organisations, other business network organisations, technology centres and science parks interested to team up around specific industrial thematic areas, in the context of industrial modernisation.

Through a dedicated call for the expression of interest, the aim is to mobilise European Strategic Cluster Partnerships for smart specialisation investments (ESCP-S3). This call is linked to the establishment of the Smart Specialisation Platform on Industrial Modernisation and Investment and is envisaged to strengthen industry participation and inter-regional collaboration in the implementation of smart specialisation strategies.

The call remains **open until the end of December 2016.**

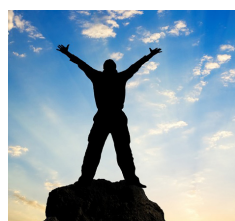
